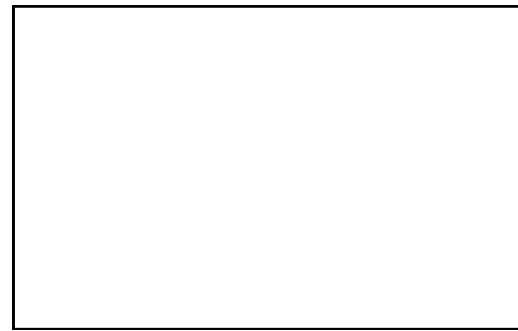

## CANCELLATION / REFUND POLICY

### Cancellation/Refund Policy

Please carefully review our cancellation/refund policy before submitting payment.

Strict adherence to this policy will be maintained, and NO exceptions will be granted under any circumstances. We have an established refund structure shall you decide to cancel your BPP bicycle vacation. Please note that the processing of a refund is based upon confirmed communication as of the date on which you communicate your desire to cancel via email ([pamperedpedalers@gmail.com](mailto:pamperedpedalers@gmail.com)) and/or telephone (206.250.3395). Refunds will be paid back with a check and mailed via US Postal within 10 days of the cancellation date.

### Cancellation Penalty Structure:

- If cancelling 150 days or more prior to the event start date there will be a \$500 cancellation penalty.
- If cancelling between 149- 91 days prior to the event start date there will be a \$600 cancellation penalty.
- If cancelling between 90-61 days prior to the event start date there will be a \$750 cancellation penalty.
- Due to contractual obligations, there will be no refund if cancelling less than 60 days prior to the event start date.
  
- This cancellation/refund policy will be enforced. If for any reason the tour is unable to start due to an Act of God, Natural Disaster or any other happening out of the tour's control, a 100% credit will be issued for any future BPP bicycle vacation, validity 2 years.
- If for any reason the tour, once started, gets interrupted before the ending location due to an Act of God, Natural Disaster or any other happening out of the tour's control, no refunds will be offered.
- No refunds or discounts will be granted for arriving later or leaving a tour prior to the scheduled conclusion.

# BICYCLE TOUR \ GENERAL RELEASE, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT

**This General Release, Assumption of Risk and Indemnification Agreement has legal consequences.**

I, the undersigned, know that this Bubba's Pampered Pedalers bicycle tour, hereafter referred to as the "Event," is a potentially hazardous event, and attend it out of my own free will and choice. In choosing to attend the Event and any related events or activities, I fully accept and assume all risks, whether before, during or after this Event and/or related events or activities. These include, without limitation, risk of physical injury, trauma or death, mental or emotional stress or injury, collision with motor vehicles of all types and descriptions, collision with other riders or fixed or moving objects, contact with other participants, communicable diseases, equipment failure, inadequate safety equipment, effects of weather including extreme temperature or conditions, traffic, , the conditions of the roads, theft, camping, participating in events or activities along the route and rides in a bus or other automotive vehicle provided or arranged for the undersigned. All such risks or risks of an event of this type are known or anticipated and are understood and appreciated by me. I waive any and all need for being given notice of the existence of any specific risks. I agree that leaders and maps are provided for my convenience only and do not guarantee a safe route or trip. I shall assume and pay my medical and emergency expenses in the event of injury, illness or other incapacity regardless of whether I authorized such expense. I realize this Event requires physical conditioning and I represent that I am in sound medical condition capable of participating in the ride without risk to myself or others. I have no medical impediment that would endanger myself or others. I understand that situations may arise during this Event that may be beyond the control of sponsors, promoters and organizers. I will be solely responsible for the condition and adequacy of my bicycle, safety gear and riding equipment. I will ride safely within the limits of my own abilities, my equipment and the riding conditions and in a manner so as not to endanger myself or others.

Knowing these facts and in consideration of my entry, acceptance, admission to and participation in this Event and its related events and activities, I, for myself and anyone acting on my behalf, waive, release, discharge and covenant not to sue Pedal Productions, LLC, a Missouri limited liability company ("PPL"), its affiliates and respective managers, members, officers, directors, employees, volunteers, agents, representatives, sponsors, volunteers, insurers and insurance brokers, and the respective heirs, executors, administrators, personal representatives, successors and assigns of all of the foregoing (collectively, the "Released Parties") from and for any and all claims, demands, actions, causes of action, damages, liabilities, attorneys' fees, costs, expenses and lawsuits, as well as any claims for any injunctions or other equitable relief, of any and every kind or nature that the undersigned has, may have or which may hereafter accrue to the undersigned against the Released Parties, directly or indirectly, arising out of or relating in any respect to the attendance of or participation by the undersigned in the Event and its related events and activities, including, without limitation, those based on or related to any negligence of any of the Released Parties, or any actions or failures to act by any of any of the Released Parties ("Claims").

- I further agree to indemnify and hold the Released Parties harmless from any and all Claims.
- I agree to abide by all the rules, regulations or instructions provided by staff or personnel conducting this Event for the safety or general welfare of the participants in the Event.
- I waive my rights of privacy or publicity and grant permission to all of the forgoing to use any photographs, motion pictures, videotapes, recordings or other record of this Event for any marketing or other legitimate purposes.
- If I am a minor, my parent or guardian is also signing on my behalf and we both agree to be bound by the same
- terms of this General Release, Assumption of Risk and Indemnification Agreement.
- If I am the parent or legal guardian of a minor child participant, I certify that the minor is in good health, qualified and in proper physical condition to participate in this Event and I hereby, for and on behalf of such minor child, waive, release, discharge, covenant not to sue, and agree to indemnify and hold harmless all of the Released Parties from any and all Claims. I will, in my own right, indemnify and hold harmless each of the Released Parties from any and all Claims in connection with the minor's participation in this Event and its related events and activities.

In the event any one or more provisions of this General Release, Assumption of Risk and Indemnification Agreement may be deemed invalid or unenforceable by any court of competent jurisdiction, but if such provision(s) were modified or severed from this document and this document would then be deemed valid and enforceable, it is agreed that such provision(s) shall be deemed so modified or severed, to the extent permitted by applicable law, to give the fullest effect to the intent of this document.

THE UNDERSIGNED HAS READ THE FOREGOING DOCUMENT AND UNDERSTANDS ALL ITS TERMS. THE UNDERSIGNED UNDERSTANDS HE HAS THE RIGHT TO CONSULT LEGAL COUNSEL PRIOR TO SIGNING AND HAS DONE SO OR HAS EXPRESSLY WAIVED HIS RIGHT TO DO SO. THE UNDERSIGNED SIGNS FREELY, VOLUNTARILY AND WITHOUT INFLUENCE FROM ANY OTHER PARTY.

# SAFETY COMMITMENT PLEDGE

The BPP Safety First Policy is made-up as follows:

- **Wear a bicycle helmet consistently while riding.**
- **Wear the provided safety vest throughout the ride.**
- **Equip my bicycle with a rear blinking light, activated while riding.**
- **Equip my bicycle with a front light, activated while riding.**
- Install a rear-facing mirror to observe approaching vehicles.
- Employ standard hand signals to announce turns.
- Refrain from using any type of headphones while riding.
- Avoid talking on the cell phone or texting while riding.
- Obey all traffic signs and signals.
- Ride defensively, maintaining awareness of other riders, vehicles, and pedestrians, avoiding assumptions about their actions.
- Point out road hazards and vocalize warnings such as "Gravel," "Hole," or "Glass" to fellow riders.
- Clearly communicate intentions to other riders, including signals for "Slowing," "Stopping," and "Turning."
- Ride in single file when a motor vehicle is behind me.
- Never ride more than two abreast, allowing ample room for other cyclists to safely pass.
- Always ride as far to the right as safely possible.
- Exercise common sense and courtesy toward motorists and fellow cyclists.
- When stopping for any reason, move completely off the roadway.
- Call out "On your left" while passing a slower rider, never passing on the right.
- Acknowledge that failure to adhere to these safety rules may result in removal from the tour without a refund.
- Commit to being a smart, safe, and savvy bicyclist.
